

2018 Legislative Update

The On-Going Saga of Medicaid Expansion Continues



According to an article in *The Richmond Times-Dispatch*, “Almost four weeks after the House of Delegates approved two budgets that expand Virginia’s Medicaid program — one for the fiscal year that ends June 30 and the other for the biennium that begins July 1 — the Senate reconvened in special session on Monday (May 14th) and referred the bills to its Finance Committee for consideration.” Updates on each bill can be found by accessing
